FEE STRUCTURE FOR LICENSED RETAILER PROGRAM

Participation in the licensed retailer program is voluntary, but does require an annual membership based on the number of stores in operation at the time the application is signed. The cost of this program for 2009-2010 is as follows:

- Allows you to display the traceability of certified product back to its sustainable source.
- Ability to use and display a clear and easily identifiable eco-label with certified products you sell.
- Provides assurance to customers that certified product has passed rigorous and credible standards for sustainable ecosystem management and the handling and husbandry of organisms.
- Places your company at the heart of a growing and effective voluntary standards movement that supports sustainability of goods and services purchased by customers on a regular basis.
- Informs your customers that you support environmental responsibility in the trade and are committed to ensuring a continued supply of marine organisms for future generations to come.
- Increases consumer recognition and understanding of the rapidly growing market for certified products.
